4. Presentation of Blackdog Housing Development by Allan Rae (Kirkwood Homes)

Allan Rae the Land Director for Kirkwood Homes, outlined his plans for the Blackdog site which has been ongoing for 7 years, he has planning consent for 550 houses, 220 of which have had a detailed layout approved in July 2019. He provided the plans and layout of the proposed development.

After the presentation the BCC discussed the above and will inform the Planning Dept that BCC do not have any concerns with the plans and would be supportive of the development in its revised form. BCC will also report to Elaine Brown (Area Manager AC) on the fact that in the initial plans there was a provision of a primary school and this has been removed at the request of the Aberdeenshire Council.

10. Landfill Tax Projects and GreenField Projects: (E. Phipps)

Balmedie Leisure Centre

- £12k shortfall overall for phase 1, currently trying to source (developer obligations fully spent)
- Car park extension commenced
- Erection of security fencing around LC scheduled for 25th November (subject to delivery of all parts)

Sensory Garden Phase 3

- BCT to apply for landfill funding early 2020
- Disabled toilet refurb BCT to apply for landfill funding to cover the building work (circa £30k)

12. External Meeting Report Back

Community Council Forum (H. Foxen M Brown main points raised)

- Other councils are having similar problems with speeding on the roads through the villages. There
 was also a problem with road closures, there is not enough information being shared with other
 councils as to when and where the roads were closed. A Couple of councils also commented on the
 fact that they do not get any police reports nor police attendance at their meetings.
- There was a suggestion that Community Councils would benefit from ad hoc workshops and they are going to email the various Community Councils on this.
- There is a leaflet that introduces Community Council's to the public to heighten within the community. If we think this would be of benefit to us, we can request from ACC
- There is a coastal community benefit fund which will be available on an annual basis, no more information is available at present, details will follow ASAP.

Formartine Rural Partnership report not available as yet (C Wood)

Investing In Communities Fund (E Phipps)

- Scottish Gov't application unsuccessful to appeal decision
- To confirm whether match funding from Area Committee is still available
- Dan & Carolyne Wood to revise project plan. They have prepared an excellent way of consulting with the public once ready to go.

Potterton Group Meeting (H.Foxen M Brown)

The woman who ran the Public Gardens resigned her post and H Foxen has taken up the challenge.

H Foxen in conjunction with E Phipps will draft an application to the Formartine Partnership Town and Village Enhancement Scheme to allow her to continue with improvements.

M.Brown requires the same for White Cairns.

1000 bulbs were received for Potterton and after a facebook message was sent out, 50 volunteers helped plant the first 500 bulbs.

14. New External and Internal Correspondence

- C Mathews (AC) asking for our scheduled BCC meeting dates and when the AGM will be, as always 3rd Monday of each month and AGM in June 2020
- Email from Maureen Pirie on 6th December, she attached a video of burning tyres, called the Fire Brigade and informed SEPA. The BCC discussed this and feel this is a Police matter, E Phipps to reply.
- Mail from R Moffat about the drains being blocked at Belhelvie and he is worried when it ices over, E Phipps to reply.

15. Any Other Business

- Speeding again an issue in the villages, D McKendrick has been trying to lobby AC for repair of
 the Balmedie speeding sign (battery replacement) and to source a replacement for the vandalised
 speed sign. There seems to be nothing forth coming from AC, the members felt it may well be a
 matter to raise with the Press.
- Xmas Lights Group have now disbanded and the mantle has been taken over by a lady from the
 Congregational Church, the lady has done an excellent job in installing the lights herself, perhaps
 next year she could count on support of BCC, BCT and volunteers from the village to help her.
 BCC to get in touch with A Cowie to propose something for next year. On December 1st the
 Village lights and Xmas Tree will be switched on and there will be carols sung.
