5. Resilience Planning Update (A McIntyre)

Community Resilience Conference 2024

Date/time: Thursday 3rd October 9.30-3.30. Location: Holiday Inn, Westhill. Description: Conference - speakers and group exercises. Organiser: Aberdeenshire Council. A McIntyre attended as part of Belhelvie Resilience Group.

Talks on first aid, What if scenario, main one was What if there was a national power cut? this is viewed as one of the highest risks to security in the country.

- 1) If there was mal function in the electrical system which could take the whole system down, or
- 2) An act of terrorism which could take the system down.

They spoke of how Community Councils would cope with no power.

A Speaker from Aberdeen Council explained how it is important that Community Councils are involved in Resilience because the Insurance policies we have with Zurich will cover the resilience effort.

ACTION: E Phipps to get clarification with Zurich that we have resilience cover in place.



6. Planning Report (G Middleton)

Validated: Extension to the back of Balmedie Leisure Centre, operations internally, to form a Café, gym, storage area and extended play area has been submitted.

Decided and Approved: Change of house types at Blackdog, Persimmons with their house style are taking over from Kirkwood.

A New house and garage at boghead (Orrock)

Merging of schools Foveran and Tipperty, the consultation on this runs from the 14th October to the 13th December 2024, there is a public meeting on the 5th December 2024 in Foveran Village Hall

7. Treasures Report and Funding Update (E Phipps)

E Phipps, transactions, website has been renewed for another year

Balmedie Path Project: E Phipps has a meeting on the 22nd October with M Hutcheon from AC Roads Department looking for the possibility of AC for availability, resource and timeline and completing doing the bills of quantity to do the two paths that were highlighted for upgrading. D Sutherland and E Macleod (Paths for all fund) will also attend the meeting. After speaking with M Hutcheon he said the timeline is tight as he has a backlog of projects until the end of February 2025. The fund itself has a March 2025 deadline so this will be tight. In the meantime there has been a FB survey with a general 6 questions asking people for a local view about the state of the paths and what they would like to see done to them, this will be used as back up for any future funding applications

H Foxen mentioned that she sits on the board of the Formartine Rural Partnership and they have available funding for various projects. E Phipps to send the details of the project after the AC meeting to H Foxen. **ACTION:** H Foxen to ask at the next sitting of the FRP if we could apply.

E Phipps has also applied to the Rural Community Lead Local Development Fund for assistance with landscape designing once the decision is made on the upgrade.

E Phipps reported there has been a knock back for funds from W Beatie for the Landfill Tax because a change in management policy by the operator. A decision to move the domestic waste to the incinerator will result in less landfill thus less revenue. This will ultimately impact W Murray at the Balmedie Leisure Centre as he is looking to extend the BLC

10. General Projects Update

Potterton Community Hall (H Foxen)

Awaiting results of village survey.

Potterton Wooden Shed

H Foxen suggested reparation of the Potterton wooden shed, a previous survey on the shed showed that there was rotting at the bottom due to the grassy area build up. After discussion the view of the BCC is this would be a costly exercise and perhaps the council were liable for the shed. H Foxen reported that the shed is used as a major storage facility by the scouts and brownies.

ACTION: Cllr Hassan will make enquiries, before any further actions by the BCC.

ACTION: Try and get an estimate for the repairs.

ACTION Completed: D Wallace tried to arrange a meeting with BCT. to discuss all the views of what each group have in mind for the area opposite to the Coop. all meeting dates were cancelled due to BCT Group being unavaiable.

New Project Development Suggestions Belhelvie Bowling Club

G Middleton spoke with the Newburgh Golf Club green manager (M Smith) and sent a set of pics for him to view. M Smith put G Middleton in touch with R Patterson a retired head greenkeeper at Royal Aberdeen GC who has a small business looking after bowling greens. G Middleton met R Patterson at Belhelvie Bowling Green and he took some core samples from the green and found the earth underneath was stinking and wet and approximately 2 inches of thatch (dead grass), he reported that it is not beyond saving but there would be quite a lot of work to bring the green to a good state, he estimated £2,500 would possibly fix this with help from the members. G Middleton then spoke with the guy who originally asked him to look into the matter and the Bowling Club cannot fund this.

ACTION: G Middleton to follow up with the Bowling Committee

There was a discussion on the costs for the bowling green and it was asked of Cllr Hassan if there could be any funding available from AC for this type leisure project. Cllr Hassan said as a constituted body we could apply to the area committee fund, but he thought it would be thin on money as we are well on in the year. Chairman said this is the kind of project we should follow up on as the Bowling green is open to all the area villages.

ACTION: E Phipps to check BCC accounts and report if the BCC can fund this, he will also talk with D Sutherland AC when he meets her for the Paths meeting (ref item 7to see if AC could provide any funding. BCC can also try funding from the Formartine Partnership when their next round of funds open.

ACTION: BCC to commit to this as a project and to paying £800 deposit to get the work started, only after G Middleton gets the go ahead from the Belhelvie Bowling Committee.

Old Tennis Courts Potterton/ Belhelvie (behind the changing rooms at the football pitch, and Bowling green) This was mentioned in a recent survey for trying to make Potterton better. The court is in a bad state and no one looks after it, AC are the land owners. This is to be put on the back burner for now along with the Belhelvie tennis court.

11. External Meetings Report Back

Formartine Partnership Meeting (H Foxen)

Not many attended the meeting, Partnership could be soon offering grants from £500 up to £5000

Country Park Meeting (A McIntyre)

The following are the key points raised at the meeting on 17th September

Paths

It was confirmed that funds had been identified to carry out the upgrade of path 2A (Between 1st path to Tormentil Crescent and the Country Park. This is going to include creating a path separate from the road to the sewage works.

Path 1 (North Beach Road) will be upgraded with future funds.

A summary of the waste management services at the Country Park was outlined. The big silver bin is emptied on a weekly basis and falls under Oliver Deeming's budget. Litter bins are emptied on a Tuesday and a Friday. The BCT have obtained 300 trees from the Woodland Trust and 300 from Apache Oil. Locations for these have been agreed with Oliver Deeming. The Leisure Centre was also successful in obtaining plants from the Woodland Trust which will be planted around the football pitches.

Flooding issues around Ice House will be monitored over the winter to see if there has been an improvement on the issue.

The possibility of requesting a police profile in the Country Park over the summer months to deter unauthorised fires is to be considered. This has proven very successful in Deeside.

Sand Bothy lease has been signed until 2041

Concerns raised over Anti-social behaviour in Magic Woods. Fire Brigade have been called out twice over the summer to deal with fires in the woods.
